3. Closed Session:

After call to order, the Special Meeting will be immediately convened in Closed Session to consult with the Authority Attorneys and Staff in regard to the following Agenda item:

Pursuant to Government Code section 54956.9(d)(4), Anticipated Litigation, one potential case; pursuant to Government Code Section 54956.9 (Threatened Litigation), claimed failure of Department of the Interior and Department of Commerce to comply with Endangered Species Act; Government Code Section 54956.9, Administrative Proceedings of the SWRCB regarding the San Joaquin River and its tributaries, and of the SWRCB in regard to adoption of a water quality control plan or emergency measures in regard to the Sacramento River and its tributaries.

No action other than direction to Staff and Legal Counsel regarding the Closed Session Reports given will be taken by the Board of Directors at the Special Meeting or adjourned Special Meetings in Closed Session. Only when a regular Meeting Notice on 72 hours advanced notice with the possible action described, or an Amended Special Meeting on 24 hours advanced notice containing a possible Action Item description, will action of the Authority be considered. Any action during a teleconference meeting will be by roll call vote.

A copy of the Notice of Adjournment of this or any subsequent Special Meeting will be posted on the Authority's office door immediately following adjournment. Notice will also be placed on the Authority's website if logical constraints permit.
