

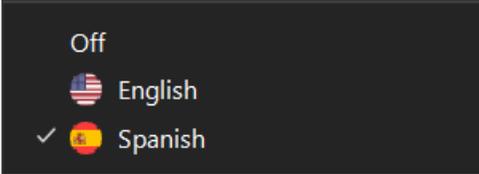

Technical Assistance

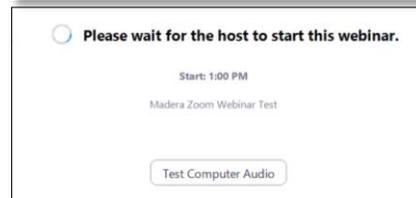
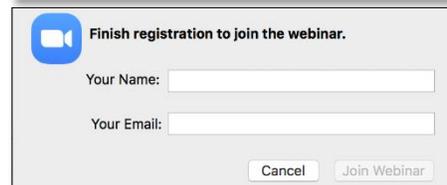
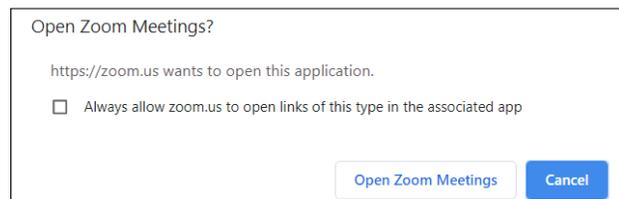
Technical assistance will be available from 3:45 – 4:00 P.M. on December 1st via the webinar or phone.

Zoom Set Up

1. Click on the webinar link above
2. Select “Open Zoom Meetings”
3. If you are new to Zoom, register with your name and email.
4. You will be placed in a virtual waiting room until the webinar opens at 3:45 P.M. for technical assistance.



Connect to Audio

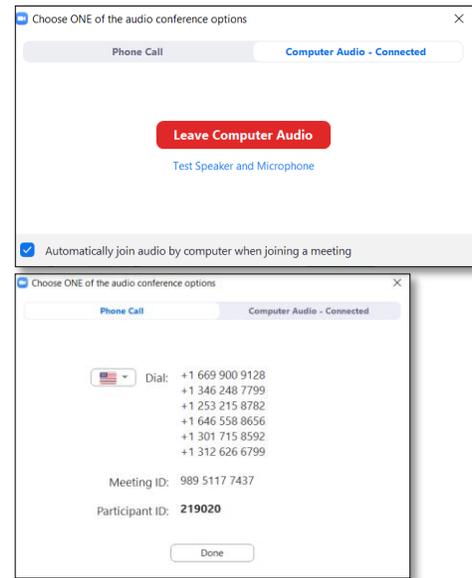
After joining the meeting, select your preferred way to listen to audio in the pop-up window:

1. Computer Audio

- a. Use this if you have a microphone and speaker in your computer and have stable internet access.

2. Phone Audio

- a. Use this if you have no or unstable internet access.



Chat



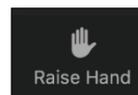
1. If you have a technical issue or clarifying question, navigate to the Chat pod at the bottom of your screen.
2. In the empty field, share your technical issue and press enter or send.

Question and Answer

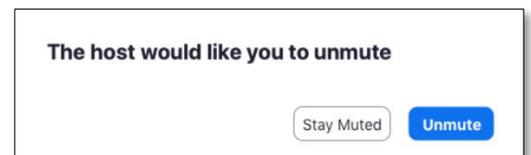


1. If you would like to ask a clarifying question, open the Question and Answer pod at the bottom of your screen.
2. Type your question in the empty field and press enter or send.
3. County of Madera staff will respond to your question either directly in the chat, verbally during time allotted for Q&A during the meeting, if time permits, or after the meeting in writing.

Raise Hand (to ask a question or share comment)



1. To ask a clarifying question verbally, select the “raise hand” button at the bottom of your screen.
2. When it is your turn to speak, a pop-up window will appear requesting you to unmute yourself. To unmute yourself, press “Unmute.”



Participating Exclusively by Phone

Dial the webinar telephone number (top of guide) and enter the Meeting ID.

1. Press *6 to unmute yourself *only when prompted* to speak.
2. Press *9 to raise your hand to ask question or share a comment.
