- The NRCS has announced FY 2022 assistance opportunities for agricultural producers and private landowners for key programs, such as the <a href="Environmental Quality Incentives">Environmental Quality Incentives</a> <a href="Program">Program (EQIP)</a>, Conservation Stewardship Program (CSP)</a>, and <a href="Agricultural Conservation Easement Program">Agricultural Conservation Easement Program (ACEP)</a>.   - Sign-up Period 1 for EQIP: December 10, 2021
  - Sign-up Period 2 for EQIP: April 1, 2022
  - EQIP Sage Grouse Initiative: May 6, 2022
  - CSP: April 1, 2022
  - ACEP: December 1, 2021
- The State Water Board (SWB) will be holding two public workshops on December 2<sup>nd</sup> and 3<sup>rd</sup>. During the workshops, the SWB will receive early input for the development of urban water use efficiency standards. The workshops will also provide a detailed overview of the methods being used to evaluate potential impacts of water use efficiency standards on local wastewater management, developed and natural parklands, and urban tree health. The meetings will also give the public, urban retail water suppliers, and other interested parties the opportunity to ask questions about the Board's analysis.

December  $2^{nd}$ 's workshop will be from 1 pm - 3 pm and will focus on wastewater management. No registration is required to attend. Please <u>click here</u> to attend the workshop.
