Minutes of the Meeting of the Board of Directors  
Clayton Water District  
held on  
December 1, 2021

1. Call to Order:  
The board meeting for Clayton Water District was called to order at 11:05 a.m. at Baker Ranch by President Larkin Harman. Board members present were Larkin Harman, Lisa Baker, Connley Clayton, and Scott Menefee. Director Eddie Gomes was absent from the meeting. Members of the public included: Gabriel Delgado, Julia Berry, Chase Hurley, Kristi Robinson, and George Park.
2. Public Comment:  
There was no public comment.
3. AB361:  
President Harman made a motion to adopt AB361 resolution for December 1 – December 30, seconded by Director Baker. The motion carried.
4. Minutes:  
Director Baker made a motion, seconded by Director Menefee to approve the minutes of the October 6, 202 Board of Directors meeting. The motion carried.
5. Treasurer's Report:
  - a) Director Clayton reported the following expenses were paid: (October) Consulting: \$5,005.00, Provost and Prichard: \$1,548.10, Legal: \$2,644.66; (November) Consulting: \$2,537.50, Legal: \$2,017.15.  
Director Baker made a motion to accept the Treasurer's report, seconded by Director Menefee and the motion carried.
6. New Business:
  - a) Director Menefee made a motion, seconded by Director Baker to set regular meeting dates for the 2022 calendar year: January 5; February 2; March 2; April 6; May 4; June 1; July 6; August 3; September 7; October 5; November 2; December 7
7. Board Member and Staff Reports:
  - a) Staff Report
    - i. Julia Berry reported that members of the district on the Madera County side met with Engineers from Davids Engineering to discuss design of the grant application for Proposition 68 funds to build conveyance from the Eastside Bypass used to spread water for irrigation and recharge.
    - ii. Berry reported that the Madera resource Conservation District reached out to inform the district that funds will be available to construct recharge

facilities and that the RCD will be helpful in supporting projects submitted by Clayton Water District.

- (b) Berry reported that the Merced County IRWM grant funding will be administered by Merced County Irrigation District and that project submittals will be required in January 2022.
- (c) Merced County GSA: Berry reported that the Technical Advisory Committee discussed potential updates to the well application filed with the County that would help inform the GSA when giving input on well approvals. One of the items suggested to be added was information from any test well drilled.

The Merced County GSA discussed the current well replacement program through the County and the challenges of operating under the current policy. There was no action taken. The board did take action to adopt a phased, 2- step approach to implementing the GSP in an effort to give landowners a chance to assimilate and to spread costs over time.

- (d) Madera County GSA: President Harman reported on the Madera County Proposition 218 election public meeting. It was estimated the County will have the opportunity to assess landowners \$165/acre in the first year if the election is successful. Projects funded by the assessment will include water rights application, land retirement program, water delivery from Sites Reservoir, and domestic well mitigation, to name a few. In January 2022, County staff will present revised rates to the board of directors for consideration, and the final rate adoption will occur in February 2022. The public hearing for final rate adoption is scheduled for April 2022, and fees are scheduled to go into effect July 2022.
