The State Water Resources Control Board (State Water Board) has opened a County-wide and Regional Funding Solicitation for counties or eligible partner entities to receive funding to implement county-wide or regional programs that address drought-related and/or contamination issues for state small water systems and domestic wells serving disadvantaged communities and low-income households.

Eligible project types may include, but are not limited to, the following:

- Assessment
 - Community outreach
 - Domestic well testing
- Interim Solutions
 - Bottled water
 - Tanks and hauled water
 - Kiosk filling stations
 - Point of Use/Point of Entry (POU/POE) installation and maintenance
- Long-Term Solutions
 - Well repairs and/or replacements
 - Limited-scale consolidation (such as laterals, above ground interties, etc.)
 - POU/POE installation and maintenance, in some cases

- During the Madera RWMG meeting on February 28th, NRCS along with Sustainable Conservation presented on a new pilot funding program for groundwater recharge (presentation slides are attached to this email). \$2 million total will be available for this pilot program, and projects must be in one of the following locations to be eligible:
 - Madera County

- Merced County (Chowchilla ID boundaries only)
- Tulare County (Tulare ID and Delano-Earlimart ID boundaries only)
- Kern County (Delano-Earlimart ID boundaries only)

Projects must either have access to recharge water from an irrigation district or have access and water rights to winter flood water. Eligible applicants include Water Management Entities (WMEs) such as irrigation districts and farm-scale applicants such as growers and landowners.

The group will vote on proposed projects to add to the IRWMP Project List for the Madera Region during the group's April meeting scheduled for April 25th at 1:30 pm on Zoom.
- The 11th International Symposium on Managed Aquifer Recharge (ISMAR 11), the world's preeminent symposium on managed aquifer recharge (MAR), is taking place April 11-15, 2022. With the continued reliance on groundwater in many areas of the world, MAR continues to be an important tool for recovering depleted aquifers and developing resilient groundwater supplies for the future. In California, MAR will play a central role in many basins to meet the requirement of the Sustainable Groundwater Management Act (SGMA).

The event is being co-hosted by the Groundwater Resources Association of California (GRA), the Arizona Hydrological Society (AHS) and the Orange County Water District (OCWD).
