

Meter Inspection Services

Pursuant to Resolution 2021-113, if a participant in the GSA's Allocation Approach ("Participant") desires to appeal the County GSA-determination on the evapotranspiration of applied water ("ETAW") for the Participant's groundwater allocation, such appeal shall be based upon use of a flow meter, and the Participant shall (1) demonstrate that the flowmeter was installed and maintained per the manufacturer's specifications, and (2) provide an engineer-certified calibration report where such calibration occurred within the last two calendar years of the appeal, in addition to other requirements. Additionally, pursuant to the penalty resolutions 2022-143, 2022-144, 2022-145, growers may choose to have their flow meters "pre-approved" for utilizing flow meter data to determine ETAW. To this end, the County issued a Request for Qualifications ("RFQ") for entities qualified to perform flow meter inspection services and, based on the responses received, a list of qualified entities was developed. The Participant shall choose a flow meter inspector from the list of qualified entities and shall contract directly with the chosen entity and pay all necessary fees and charges for the services performed. The County GSA does not warrant, either expressly or impliedly, the services performed by the selected flowmeter inspector, but reserves the right to review the inspector's conclusions for purposes of the appeal. The Participant assumes any and all risks and liabilities associated with the work of the selected flowmeter inspector under any contract with the Participant, and County is not a third-party beneficiary under any such contract.
