 DWR is currently accepting applications for its County Drought Resilience Planning Assistance Program. This program intends to help counties establish standing drought task forces or to develop the county drought resilience plans, per SB 552. The application deadline is December 29th, and award announcements will be made on a rolling basis from May 2023 – June 2024. Projects awarded will have an implementation period of 2 years. \$5M total is available in funding, with each individual award expected to be between \$10,000 and \$125,000.  CAL Fire is currently accepting applications for its California Forest Improvement Program (CFIP) with multiple deadlines happening once every 2-months. Deadlines are May 1st, July 1st, September 1st, and November 1st.

The purpose of this program is to encourage private and public investment in, and improved management of, California forest lands and resources. This focus is to ensure adequate high quality timber supplies, related employment and other economic benefits, and the protection, maintenance, and enhancement of a productive and stable forest resource system for the benefit of present and future generations.
