Governor's Executive Order N-4-23 For Flood Diversion

Thank you for helping with groundwater sustainability!

All authorized flood flow diverters who have stopped diverting must file a final report to the State Water Resources Control Board and to the Madera County Water & Natural Resources Department within 14 days of when the diversion ends.

LAND REPURPOSING

Land repurposing is a voluntary, compensated program that provides an incentive payment to growers in exchange for Sustainable Yield and Transitional Water allocations. Madera County GSA is implementing three Land Repurposing programs, described below, as part of its demand management actions to achieve groundwater sustainability for the subbasin.

Friendly Reminders!

Don't forget that your meter readings are due to the <u>flowmeter portal</u> by the 10th of each month! You will be shifted to Land IQ if you do not submit your readings, but you will still be able to use your meters as a back-up measurement.

If IrriWatch is your measurement method, your reports for the previous month will be live around the 10th of the month.

If you chose Land IQ as your measurement method, you will receive hard copies of your reports as soon as humanly possible.
