



FUNDING OPPORTUNITIES

Almond Alliance



<u>The Almond Alliance</u> and Great Valley Seed have partnered to develop native plant and seed supplies. These supplies will be made easily accessible to California's almond growers to expand pollinator habitat on 7,600 working farms.

This farmer-to-farmer solution, the Almond Alliance and Great Valley Seed Pollinator Habitat Partnership, harnesses the sophistication and excellence of California's almond farmers to grow habitat, promote pollinator health and biodiversity, and further develop native seed and nursery stock for continued habitat restoration on California's working lands.

CDFA Dairy Plus Program

There is still time to apply for CDFA's <u>Dairy PLUS Program</u>. The application window closes on 8/28/23!

The program has \$75M that will be deployed over the next 5 years to support Advanced Manure Management practices. For farmers that already have subsurface drip irrigation systems, there is an opportunity to receive funding for incorporating manure effluent as a fertilizer replacement in combination with other eligible practices under the Alternative Manure Management Program (AMMP) and the Dairy Digester Research and Development Program (DDRDP). Technical Assistance is being provided by UCANR Climate Smart Agriculture Community Education Specialists who are available to help answer questions from farmers who are interested in applying. Subsurface Drip Irrigation


What's better than one funding opportunity? Two!

Are you currently flood irrigating and interested in converting to subsurface drip irrigation (SDI)? A large beverage company that is seeking water savings from the conversion has a contract that equates to \$105,000 (or about half the cost of the system) that would be paid over three years. Water savings will be tracked via a water meter and cross referenced with evapotranspiration data. Private Meter Submission Autoreplies

Great news! If you are using private meters as your measurement choice, you will now be receiving a SMS autoreply message within two minutes of making your monthly meter submission! Don't forget to upload your photos once a month between the first and tenth. Make sure to take a photo even if you are not pumping!



Irriwatch – You should see monthly reports on the Irriwatch portal around the tenth of the month each month.

LandIQ – Your reports will be mailed to you ASAP. The reports for June went out at the beginning of August via USPS.

RECHARGE

Executive Order N-10-23

Executive Order N-10-23 acknowledges the need for expedited removal of debris and vegetation from impacted areas before the next rainy season to mitigate flooding and support recovery efforts. It suspends certain regulations and requirements to facilitate emergency activities, including repair and maintenance of infrastructure, sediment removal, and vegetation management. Specific conditions and criteria must be met for these emergency activities to

take place, ensuring they are necessary, environmentally responsible, and completed by November 1, 2023.

New SGMA Brochure



DWR has released a <u>brochure</u> that provides an overview of the elements in the Sustainable Groundwater Management Act (SGMA). In 2014, SGMA was passed to create a statewide framework that would provide long-term protection of groundwater resources. The brochure describes benefits of SGMA and includes DWR resources to help with SGMA compliance. A <u>Spanish version</u> of the brochure is available.
