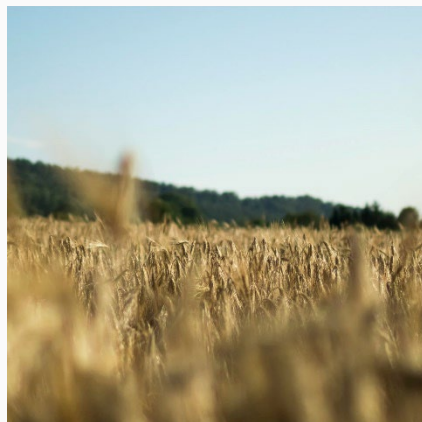

MLRP Project Portfolio Public Comment Period

The Madera County Multibenefit Land Repurposing Program (MLRP) has completed the competitive project scoring and selection process. Six projects were selected for primary funding consideration, with three additional projects included as runner-ups in the portfolio recommendation.

Public Comment Period: June 11 to 27, 2025

Community members and stakeholders are invited to review the project portfolio and provide feedback for consideration before projects are submitted to the California Department of Conservation for review.
