He spoke with Jon and they are going to start planning a school project at Sherman Thomas Elementary. They just planted another pollinator project in December right before the rain event. The La Vina Project will distribute native seeds depending on climate. We have another being planned for implementation in 2026. He is working on getting these projects uploaded to RCD project tracker.
