November 13, 2025

Roll Call: Director Lucas Avila called the meeting to order at 2:00 pm.

Public Comment

No public comments were made.

Minutes

Minutes from the Board Meeting September 11, 2025 were reviewed. Director Dirk Vlot made a motion to approve the minutes, and Danielle Harris seconded. The motion passed.

Subbasin Report

Sarah Woolf reminded the board of the approved contract with David's Engineering to do the Groundwater Demand Management & Subsidence Mitigation Measures Support for the basins, and that we should have a draft policy in January. Sarah said there was good discussions at these meetings

Sarah reviewed a report showing identifying the cost of the Appropriate Water Right to date, noting the increase in activity and expenditures this year and the good amount of progress made. Sarah said that next year, we could see resolution coming from the State Board. We anticipate similar expenditures for engineering and legal for next year. We collected \$18 per acre from all of the participants in the Appropriate Water Right group initially, and we have spent \$22 per acre, so we will need to put out a request for additional funds. The group reviewed line items and discussion followed.
