Background of Transfer

A 2024 groundwater overuse penalty was issued to a master account in the Madera Subbasin

The penalty was overturned following an approved appeal

A refund memorandum was issued to the master account

Transfer of Appropriations 25-068 implements the appropriate accounting process to reimburse the master account

Process of Transfer

- **Refunds and Reimbursement** account in the GSA Adm. Fee Budget is used for Refunds and Reimbursements
- Transfer of Appropriation No. 25-068 moves \$26,120 from:
Appropriation for Contingency → Refunds & Reimbursements
- Payment to the master account can then occur

Staff Recommendation

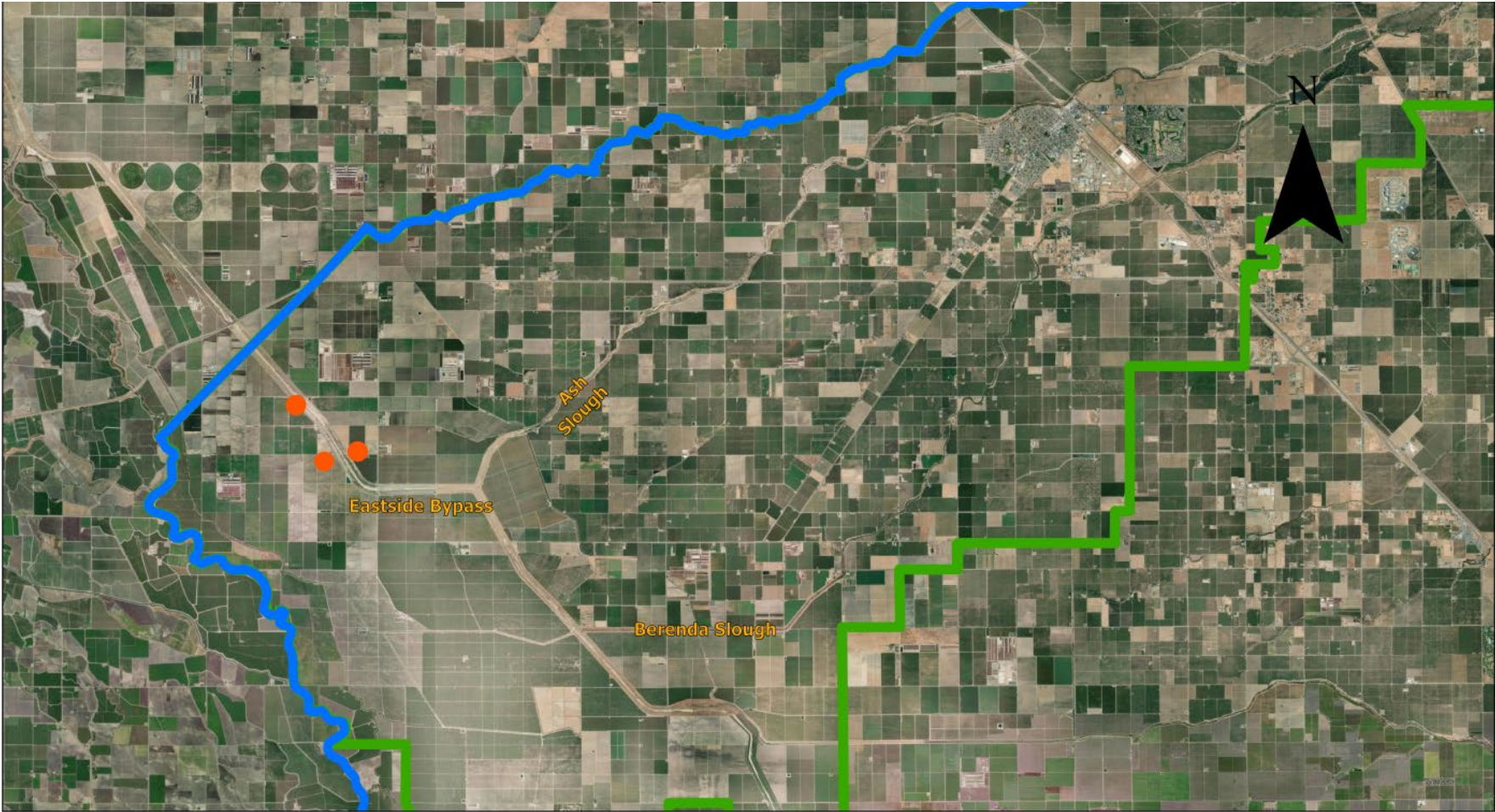

Initial bid: November 19, 2025

- Madera County Public Works Department standard bidding process used
- Initial pre-bid meeting hosted 13 businesses
- Bids opened on December 15, 2025
- Received one responsive bid
- Bid was rejected due to the proposal exceeded available grant funds for the base project

Rebid: January 2, 2026

- Due to lack of grant funding, scope of project was reduced for the rebid
- Madera County Public Works Department standard bidding process used
- 17 businesses attended the pre-bid meeting
- Bids were opened on January 28, 2026
- Received 4 responsive and responsible bids
- As soon as the protest period is over the project will be awarded to the lowest responsive and responsible bidder

Background

The California Code of Regulations Title 23 (23 CCR) §356.2 requires that GSP Annual Reports be submitted to the California Department of Water Resources by April 1 of each year following the adoption of a GSP

DWR requests that the Madera Subbasin submit one 7-party annual report (in addition to the individual GSP reports)

Costs have been shared among the seven parties as done in the past

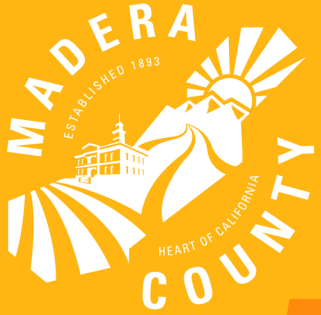
Staff Recommendation

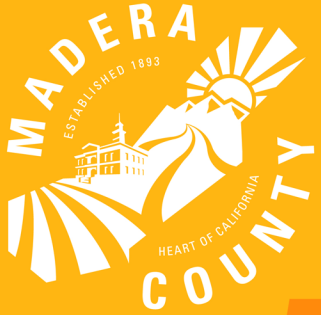

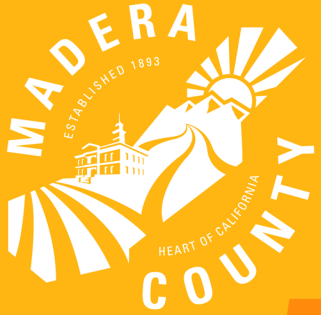

Background

May - Issued RFP for measurement/platform

- Seven proposals were received

July - Public presentations at the GSA committee

- Questions collected from growers after public presentations
- Grower review period until end of July
- Considerable objection to purchasing a platform – 41% said no

October – Webinar for growers based on top three platforms (as voted by growers)

November – Follow up questionnaire to growers on groundwater accounting platforms (only)

Key Functionality for Groundwater Accounting Platforms

- Track water usage from any remote sensed and metered data source
- Show available water supply, including allocations, recharge, and other credits
- Visualize water usage at the field, parcel, and account scales with grower-facing dashboards

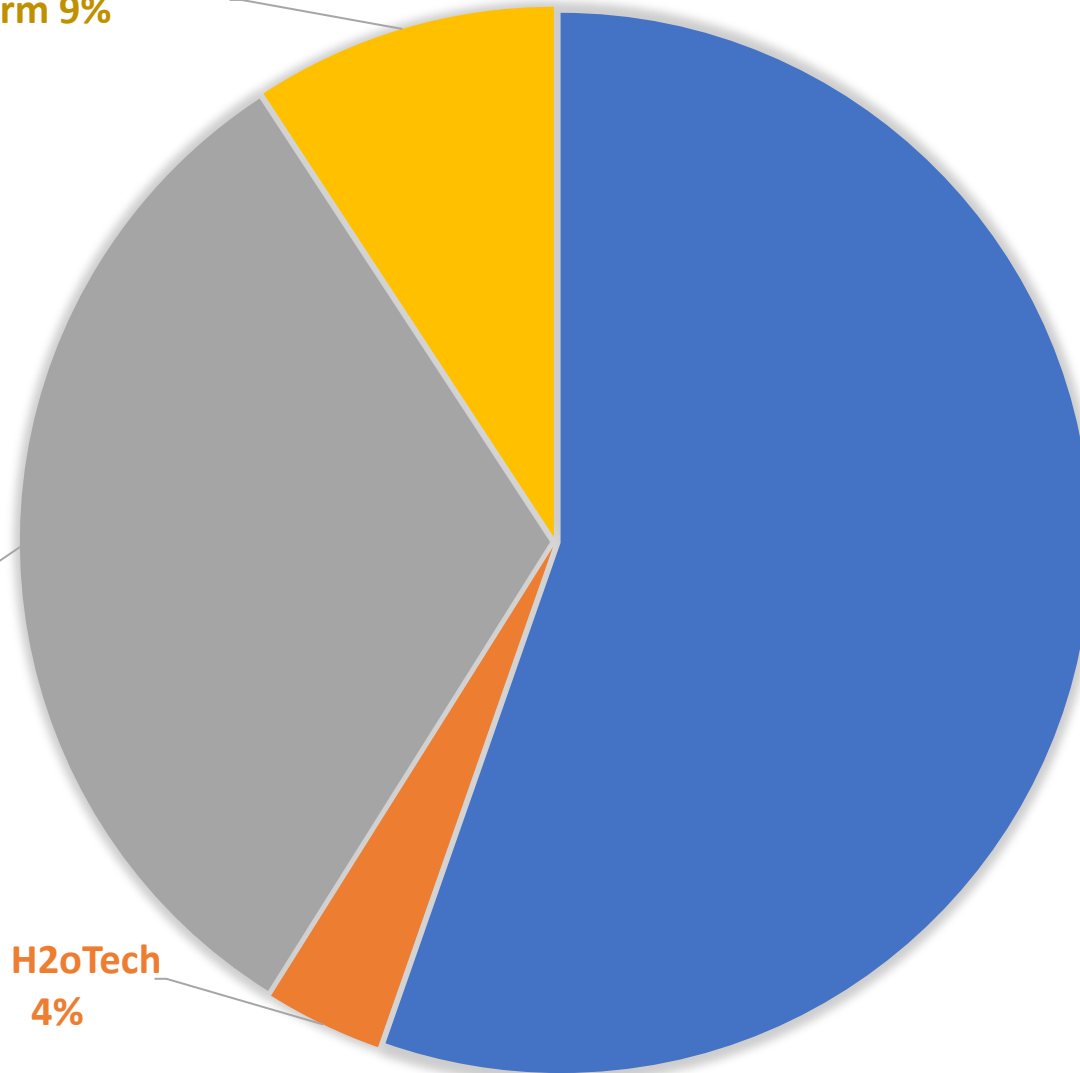
GROUNDWATER ACCOUNTING PLATFORM QUESTIONNAIRE BY NUMBER OF APN

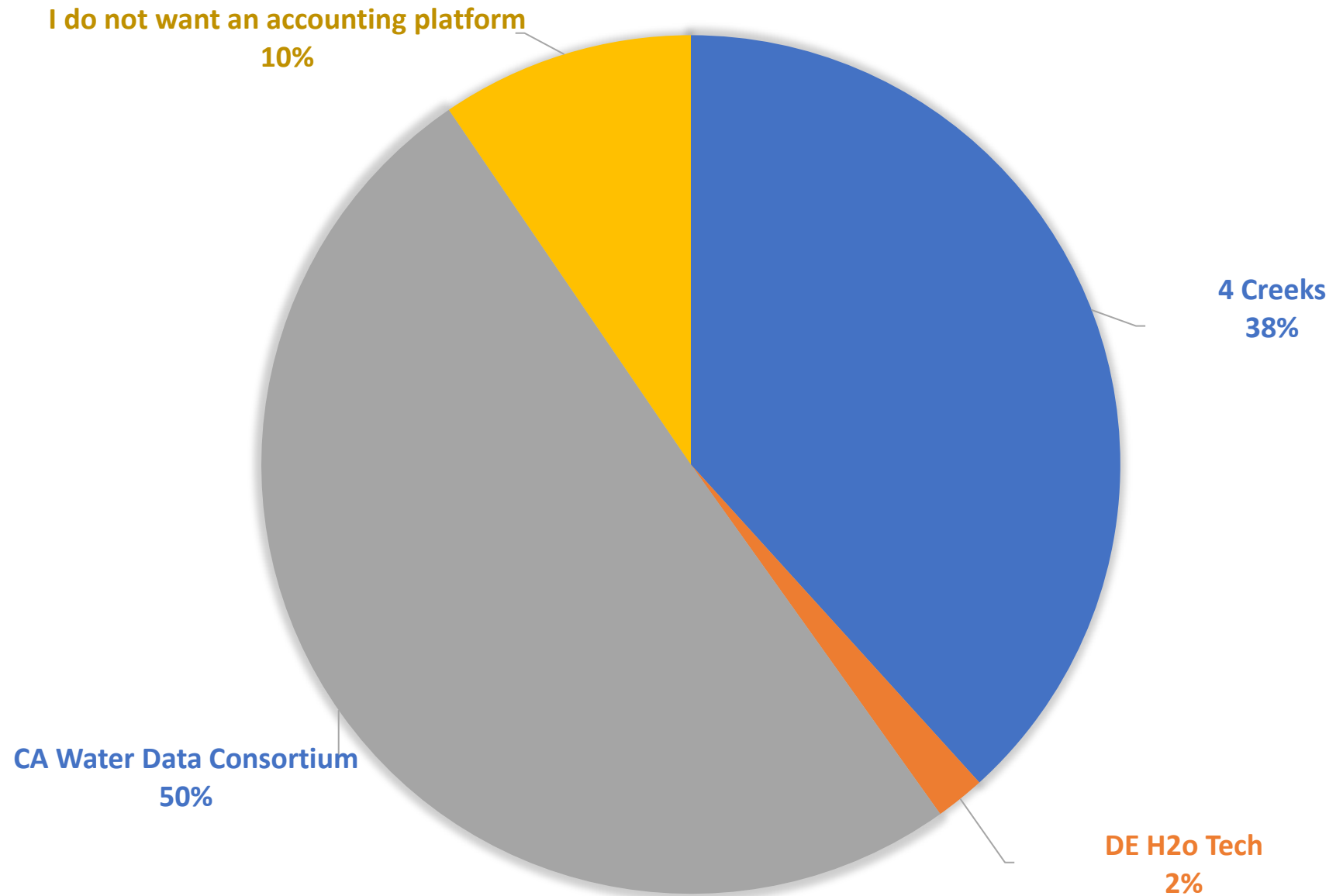

GROUNDWATER ACCOUNTING PLATFORM QUESTIONNAIRE BY ACREAGE

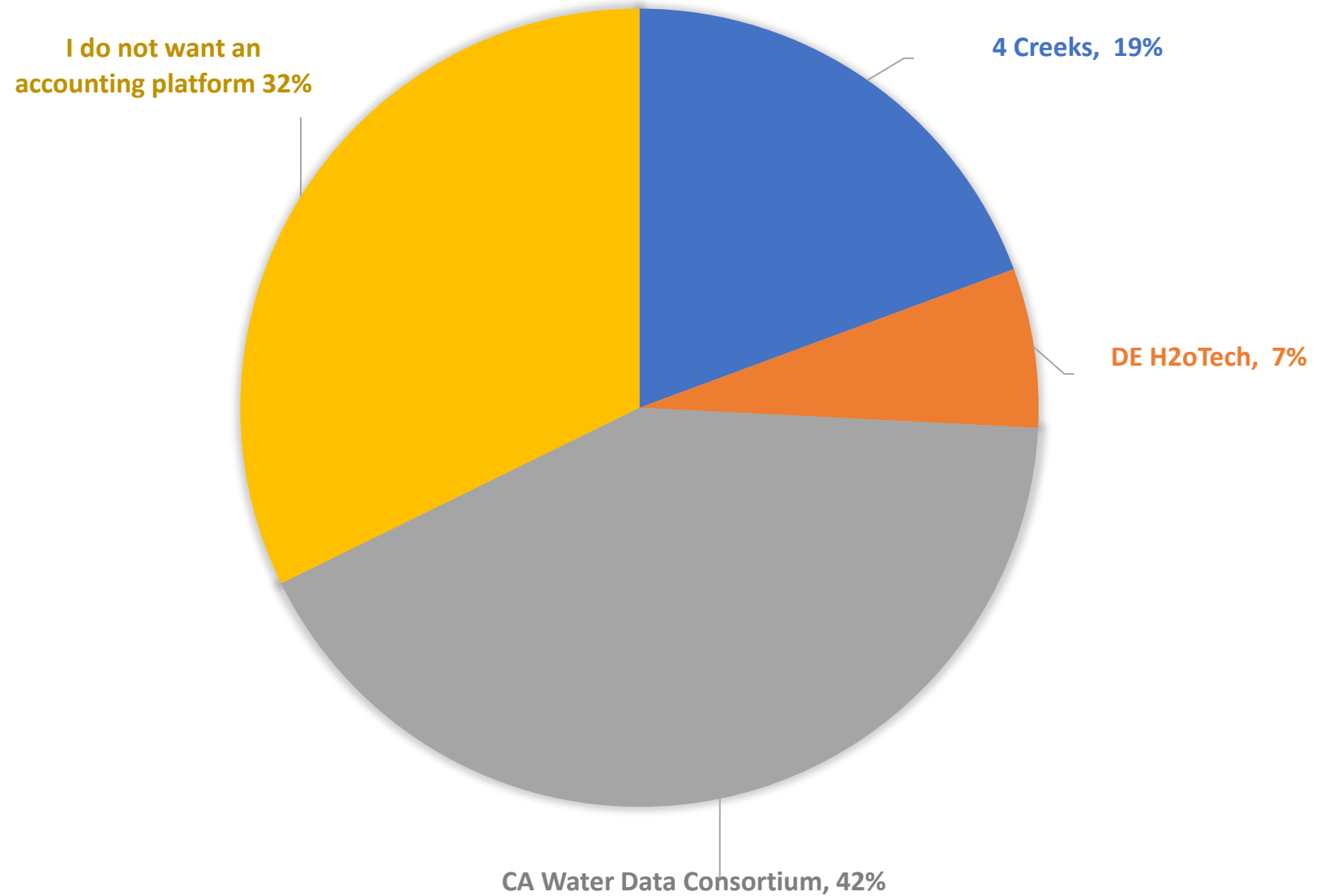

Next Steps

- Significant opposition to the groundwater accounting platform despite educational efforts and presentations by potential vendors
- Conflicting responses in terms of top choice
- Reference checks suggested that base cost escalated quickly when customized; “it’s not plug and play”
- Staff recommendation: Wait until fall and revisit.

- GSP Project Fee was previously approved and is currently being collected for domestic well mitigation only
- Action appropriates \$2.4 million in collected, unbudgeted GSP fee revenue
- Projects address groundwater overdraft and advance SGMA implementation
- No General Fund impact

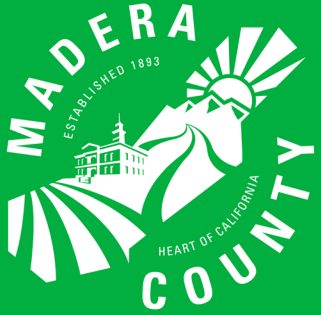

Revised Process & Amended Resolution

Process

Apply: Complete and sign the application and submit a \$100 deposit that will be credited towards payment if qualified. **The deposit is non-refundable for applicants that do not qualify.**

Assessment: The Madera County GSA or its agents will conduct a well assessment.

Approval: **If the well qualifies, the landowner will solicit and provide the GSA with three (3) bids from well drillers. Two (2) bids must be from the Madera County GSA qualified well driller list. The County GSA will approve one of the bids and authorize work to begin.**

Payment: **The GSA will advance the landowner up to \$35,000 in eligible costs on a schedule deemed appropriate by the GSA. At completion the landowner must provide sufficient documentation to support the amount advanced by the GSA.**

Record: After completion, the mitigation record will be filed on the property deed with agreement terms.

Resolution

Signing Authority: **Grants authority to Director to approve qualified projects according to criteria.**
